

## Rules and Conditions for Approval of Outside Dining on Public Sidewalks

- Each restaurant location will be reviewed and permitted individually.
- Outside dining permit expires December 31 of each year, and must be renewed annually.
- Business must submit documentation showing the City of Waterloo listed as Additional Insured.
- Unobstructed sidewalk must be maintained at all times.
- 50% of business sales must be other than alcoholic beverages.
- Restaurant will be responsible for cleaning and maintenance of any eating area.
- Seating area will be protected from pedestrian traffic by either fencing or large planters with plantings, of at least 36" in height, as approved by Zoning Administrator.
- Alcoholic beverages may be served as long as food is being ordered or served at the same time. Outdoor seating is not allowed for the consumption of alcoholic beverages only.
- Outdoor seating area must close within a reasonable time of the closing of full-service kitchen.
- Violation of any of the above Rules and Guidelines will be grounds for immediate revocation of permit.
