Director of Public Works – **Tim Birk** distributed maps of wards. He attended the IDOT meeting in Collinsville regarding Moore Street Phase 5 and federal funds will be \$487,000 and this project is to begin in 2019. Discussion. One project for 2016 will be Hamacher/Osterhage/Bradford. Discussion. The Park & Ride project began Friday (May 8, 2015). The Main and Mill Streets repairs will begin tomorrow (May 12, 2015). The Project at the Court House is done. Tim stated 'chalk only' is to be used to mark streets downtown. Discussion. The trees downtown will be removed. Discussion. Tim informed the Council of the specific species of fish discovered in the proposed Mockingbird detention pond with the Illinois Department of Natural Resources attempting to save the species. Discussion. The Lakeview Drive project will begin May 26, 2015 from route 156 to City Lakes: Hanks Excavation is scheduled for the work. Proposals for generators on S. Library and Legion at a cost of \$48,435 for 2 and the City will do this project. The siren at the Sewer Plant needs replaced; the Council agreed to this replacement.

Chief of Police-Jim Trantham distributed information regarding 'Police Deadly Force Events: How Municipal Officials Should Prepare and Respond' from the seminar he attended Friday, May 8, 2015 in O'Fallon, Illinois. Chief Trantham spoke on Transparency in Police Departments, Accountability and the Law, Leadership, Support and Dealing with the Media. He reported on the methamphetamine lab raided in Waterloo on Thursday, May 7. Ordinance No. 2536 has been adopted by the City of Columbia wherein it requires abatement of methamphetamine contamination of buildings or structures in the city. Discussion.
