  - Mayor Smith and City Attorney Dan Hayes explained that this ordinance amendment is only to add the term, and definition, of "Recovery Residence" as a Special Use Permit in a B2 General Business District. If the ordinance is amended, a special use permit would need to be submitted for approval by the City of Waterloo Planning Commission and the City of Waterloo Board of Appeals. A lengthy discussion was held on this ordinance amendment with opinions expressed from the community. Most of those who were in attendance spoke for the ordinance change, however, several community members spoke in opposition to the proposed amendment.
