**1. Petitions by Citizens on Non-Agenda items – None**

**2. Approval of the previous 04-04-2022 Ordinance Committee Meeting Minutes**

Motion made by Notheisen to approve minutes as written, 2<sup>nd</sup> by Heller, unanimous.

**3. Discussion regarding number of Police Sergeants**

Chief Jeff Prosize recommends the City going to 4 Police Sergeants.

Motion made by Notheisen to accept Jeff Prosize recommendation, 2<sup>nd</sup> by Hopkins unanimous recommendation.

This will be effective after The City receives a New Sergeants List and after City Council has approved the ordinance.

**4. Review and Discussion on modifying the Mobile Truck Vendors Ordinance**

Nathan Krebel distributed Article X: Mobile Truck Vendors 7-10-1

Lengthy discussion about Ice Cream Trucks and The Drivers.

Under 7-10-1 Definitions heading “Food Truck”, the sentence “A Food Truck Vendor does not include an ice cream truck operator should be deleted from this description.

A new definition immediately below **Food Truck** will be added **Ice Cream Truck Vendor**.

The new definition will include, but not limited to **1)** Sale of Individually Packaged Items only **2)** Crowd Sourcing through Social Media to identify a location is prohibited **3)** A Valid Photo ID will be required for all Drivers, Employees, etc. in the Ice Cream Truck.

Nathan Krebel will write this up and submit to City Attorney Natalie Steppig for review and then back to an Ordinance Meeting.

**5. Review & recommend to Planning Commission on conflicting Home Occupation Signage Ordinance (40-4-15(P)) and Home Occupation Definition.**

Nathan Krebel distributed Home Occupation 40-4-15

Discussion about appropriate sign size, etc.

Recommendation to add 12”X12” Sign to the definition.

## **6. Comments**

City attorney Natalie Steppig stated that we need to change the Ordinance to avoid taking the Electric Rate Increase.

The Finance Committee should meet regarding an increase to Aldermen Annual Income, Annual Increases, and Committee Meeting Pay.

Nathan Krebel stated that he needed to review Improvements Plans for Silver Creek Phase II with regard to Ownership.

Alderman Jim Hopkins voiced concern about mobile Basketball backboards on City Streets. Brad Yearian or Chief Prorise should notified if these are observed on any City Street.
